## CAMPSITE REGULATIONS

### **1 – CONDITIONS OF ADMISSION**

In order to be allowed to enter the campsite and set up on it, one must have been given permission by the member of staff at the reception (or the campsite owner). Residence on the grounds of the Camping du Jard campsite implies an understanding and acceptance of the rules laid down in the internal regulations and an undertaking to abide by them.

### **2 – REGISTRATION REQUIREMENTS**

Any person wishing to spend at least one night on site must firstly register at the reception in order to complete the necessary formalities regarding ID, etc.

### **3 – INSTALLATION**

All tents, caravans and other equipment must be installed on the site position indicated by the manager. Campers holding an advanced booking contract must not have his caravan or his tent pitched by a third person without informing the manager.

### **4 – RECEPTION**

Open from 9:00 to 12:30 and from 15:30 to 20:00 in high season and from 9:00 to 12:00 and from 16:00 to 19:00 in low season. Information is available upon request for the following : Site installation, local sightseeing, sports facilities, place to eat. Of course, the reception staff are available to answer any other enquiries.

### **5 – SITE FEES**

Site fees are payable at the reception (rates are shown at the reception). The amount is calculated according to the number of nights spent on site (Arrival after 13h00 for a pitch - Departure before 12h00 / Arrival after 16h00 for a renting - Departure between 08h00 and 10h00). Campers must pay the final balance on arrival and the management must be informed at least one day in advance of the day of departure.

### **6 – NOISE AND SILENCE**

Campers are requested not to be inconvenient to others by loud noise (music, shouting, etc...) . All sound apparatus must be set at minimum volume and care should be taken when closing doors and car boots (there must be absolute silence between 23h00- 08h00)

### **7 – VISITORS**

All persons wishing to enter the campsite must first seek permission from the reception manager. Any patrons friends must present themselves at reception before entering the campsite. All visitors are under the responsibility of the patron. Visitors will be asked to pay an entrance fee before entering the campsite. They have to leave their car in the car park. Visitors must leave the campsite before 22h00. Visitors are strictly not permitted to use the swimming pool

## **8-ANIMALS**

Small size dogs are accepted with an extra charge, except for category 1 and 2 dogs (pitbull, rottweiler, etc....). Your pet must be kept on a leash. Vaccination book to be presented on arrival. All undeclared animals can be refused. Your pet must not be left alone in the accommodation.

## **9 – VEHICLES**

The speed limit within the campsite is 5 km/h. Driving is not permitted in the campsite between 22h30 and 07h00 (car, motorbike, bicycle, etc...) The only vehicles allowed are those belonging to patrons. Vehicles temporarily parked on the site roads must not hamper movement of traffic for newcomers installing tents, caravans, etc... The parking of vehicles on vacant pitches is strictly forbidden.

## **10-Swimming pool and Spa**

Open from 01/05 to 20/09. Swimming shorts and long johns are not allowed. Only swimsuits are allowed. The Spa area is reserved for people over 16 years old.

## **11 – MAINTENANCE AND APPEARANCE OF INSTALLATIONS**

At the pool, only swimming briefs to be worn; no shorts. Each camper is responsible for this installation and for the cleanliness of his emplacement. Chemical toilets and waste paper must be emptied in the places provided and not on the ground or in the drainage system. Washing must be done in the tubs provided on site. Washing must only be hung on drying frames and the fixing of clothes lines is strictly forbidden. Patrons are advised that the washing of cars on the campsite is not permitted. Patrons must not cause any damage whatsoever to the grass, trees or any of the campsite facilities. Please walk or drive on roads only

## **12 – SAFETY AND SECURITY**

- A) FIRE : wood charcoal fires are strictly forbidden. Gas cookers must be in good working order and must not be left burning unattended (free on-site grill). Fire extinguishers are available around the campsite. In case of fire the management should be contacted immediately. A first aid kit is available on request at the reception
- B) THEFT : the site management can only accept liability for those objects deposited at the reception. If you see any person acting suspiciously on site, you should immediately inform the manager. All thought there is a good security system on site you should take the usual precautions to protect your belongings

## **13 – SPORT**

Noisy and disruptive games are not permitted near the pitches. There may be no noisy games in the assembly room.

## **14 – MANAGER**

Authority for the conduct of the site is vested in the manager. The management reserves the right to request any person breaching the regulations to leave the campsite. We trust that rules will enable all patrons to enjoy a comfortable and relaxing stay at Camping du Jard. Thank you Children must go to the swimming pool and activities on the campsite with their parents. The campsite cannot be responsible in case of an accident.
